WHEREAS, in terms of section 14(1) of the NCTE Act, 1993 Tara Chand Vdic Putree Degree College, Plot No-580/15/27, Village-Muzaffar Nagar, Post-New Mandi, Tehsil-Muzaffar Nagar, District-Muzaffar Nagar-251001, State-Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for B.Ed Course of one year duration with an annual intake of 100 (Hundred Only) students on 26.06.2008.

AND WHEREAS, the inspection of the institution was conducted on 30.08.2009 and the application submitted by the institution, the documents attached therewith, the affidavit, input received from the visiting team in the form of report/ videography and the input received from, recommendation of the State Government, the Northern Regional Committee in its 154th Meeting held from January 09-11, 2010 and NRC decided to show cause notice on certain points. Accordingly, show cause notice was issued to the institution on 19.01.2010.

AND WHEREAS, the reply was considered by the NRC, in its 157th meeting held from 24th to 27th March. 2010 and committee decided that VT may be sent again and the deficiency letter issued to the Institute should be given to the VT members.

AND WHEREAS, the re-inspection of the institution was conducted on 31.05.2010 and the application submitted by the institution, the documents attached therewith, the affidavit, input received from the visiting team in the form of report/ videography and the input received from, recommendation of the State Government, the Northern Regional Committee in its 162nd Meeting held from 24th to 27th June, 2010 and NRC decided to show cause notice on certain points. Accordingly, show cause notice was issued to the institution on 05.08.2010.

AND WHEREAS, the said institution filed a writ petition No. 72893/2010 in the Hon'ble High Court of UP at Allahabad and the Court had passed and order dated 06.12.2010. The said order was considered by the NRC, in its

AND WHEREAS, the reply of the institution dated 16.08.2010 with reference to the Show-cause notice dated 05.08.2010 was carefully considered by the NRC, in its 177th Meeting held from 27th to 29th January, 2011 and NRC decided that the Institution be issued Letter of Intent Prior to Recognition under clause 7(9) of the NCTE Regulation, 2009. Accordingly, letter was issued to the institution on 17.02.2011. The reply of the Institution dated 1.3.2011 has been considered by the NRC. in its 180th meeting held from 23rd March to 26th March, 2011, 31st March to 1st April and 9th April to 11th April 2011 and committee decided to show cause notice.

AND WHEREAS, the reply of the institution dated 01.03.2011 and the original file was considered by NRC in its 183rd Meeting held from 30th May to 4th June, 2011 and NRC decided that the Formal Recognition order under clause 7(11) of the NCTE Regulation, 2009 for 100 seats in B.Ed. course for the session 2011-2012 be issued to the institution.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Tara Chand Vdic Putree Degree College, Plot No-580/15/27, Village-Muzaffar Nagar, Post-New Mandi, Tehsil-Muzaffar Nagar, District-Muzaffar Nagar-251001, State-Uttar Pradesh for conducting B.Ed. One year Course with an annual intake of 100 (Hundred Only) students from the academic session 2011-2012 under clause 7(11) of NCTE Regulations subject to the following conditions:

- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated alongwith an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as ii) amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause iii) 8(12) of the NCTE Regulations, 2009.

Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

- · Copy of the Application Form
- · Land and Building Particulars
- Staff Profile
- · Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules. Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993.
